SCRUTINIZER'S REPORT

To,

The Chairman of

47th Annual General Meeting of the Shareholders of Banswara Syntex Ltd held on Saturday, 5th August, 2023 at 05:00 P.M. at the registered office of the Company at Industrial Area, Dahod Road, Post Box No. 21, Banswara- 327001 (Rajasthan) ("AGM").

Sub: Consolidated Scrutinizer's report on remote e-voting and voting conducted at the AGM.

The Board of Directors of Banswara Syntex Ltd (hereinafter referred to as "Company") at its meeting held on Monday, 15th May, 2023, has appointed me as the scrutinizer for the remote e-voting process as well as to scrutinize the physical ballot forms to be received from the Shareholders at the venue of the AGM pursuant to Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) (hereinafter referred to as "Rule 20") and in accordance with Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.

The management of the Company is responsible to ensure compliance with the requirements of the Companies Act, 2013, Rules and circulars issued by MCA and SEBI relating to conducting of AGM. My responsibility as a Scrutinizer for the voting process is restricted to making a Consolidated Scrutinizer's Report of the votes cast "in favor" and/or "against" the resolutions stated in the notice of the AGM, based on the physical ballots and report generated from the e-voting system provided by Central Depository Services (India) Limited, the Agency engaged by the Company to provide remote e-voting facilities.

Report on Scrutiny:

- The Company had appointed Central Depository Services (India) Limited (hereinafter referred to as "CDSL / Service Provider") as the Service Provider for the purpose of extending the facility of remote e-voting to the Shareholders of the Company. Computech Sharecap Ltd is the Registrar and Share Transfer Agents (hereinafter referred to as "RTA") of the Company.
- The Service Provider had provided a system for recording the votes of the Shareholders electronically on all the items of the business (both Ordinary and Special Business) sought to be transacted at the AGM of the Company.
- The Service Provider had set up electronic voting facility on their https://www.evotingindia.com. The Company had uploaded all the items of the business to be transacted at the AGM on the website of the Company and also the Service Provider to facilitate their Shareholders to cast their vote through remote e-voting.
- The internal cut-off date for the dispatch of the Notice of the AGM was 7th July, 2023 and as on that date, there were 13,045 shareholders of the Company. The RTA had sent the Notices of the AGM along with Annual Report and E-Voting details by e-mail to 9,788 shareholders whose email IDs were made available by the two Depositories and for those shareholders, holding shares in physical form, who had registered their email IDs with the RTA. In respect of 3,257 shareholders whose e-mail IDs were not available, notices were sent by courier.

 The notices sent (both through e-mail and physical mode) contained the detailed procedure to be followed by the Shareholders who were desirous of casting their votes electronically as provided in Rule 20.

- The Company completed the dispatch of the notices to the Shareholders by 10th July, 2023.
- As prescribed in clause (v) of sub rule 4 of Rule 20 of The Companies (Management and Administration) Rules, 2014, the Company also released an advertisement, which was published more than 21 days before the date of the AGM in "Business Standard" English newspaper in English language and in "Business Remedies" Vernacular newspaper in Vernacular language on Wednesday, 12th July, 2023. The notice published in the newspaper carried the required information as specified in Sub Rule 4(v) (a) to (h) of the said Rule 20.
- The Cut-off date for the purpose of identifying Shareholders who will be entitled to vote on the
 resolutions placed for approval of the Shareholders was Saturday, 29th July, 2023. The remote evoting period remained open from Tuesday, 1st August, 2023 at 09:00 A.M. and ended on Friday,
 4th August, 2023 at 05:00 P.M.
- At the end of the voting period on Friday, 4th August, 2023 at 05:00 P.M., the voting portal of the Service Provider was blocked forthwith. The limited information for the shareholders who have cast their votes, such as name, folio number and number of shares held was obtained from the Service Provider.
- At the venue of the AGM of the Company, the facility to vote through ballot paper was provided
 to facilitate those Shareholders present in the meeting but could not participate in the Remote
 e-voting to record their votes.
- After the voting at the AGM was concluded, ballot box kept for the purpose of casting of votes was locked in my presence with due identification marks placed by me. The locked ballot box was subsequently opened in my presence and in presence of two witnesses and the ballot papers were diligently scrutinized. The ballot papers were reconciled with the records maintained by the Registrar and Transfer Agents of the Company and the authorizations/ proxies lodged with the Company. The ballot papers, which were incomplete and/or which were otherwise found defective have been treated as invalid and kept separately.
- After counting of the votes conducted at the venue of the AGM through ballot paper, the votes
 cast through remote e-voting were unblocked by me in the presence of two witnesses who are
 not in the employment of the company as prescribed in Sub Rule 4(xii) of the said Rule 20.
- Thereafter, I as a scrutinizer duly compiled details of the remote e-voting carried out by the Shareholders and the physical voting done at the venue of the AGM by way of Ballot paper, the details of which are as follows:
